Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing/lending company and time shares/club shares/membership certificates issuers or selling agents thereof; nor to operate a fiat money to virtual currency exchange. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

### ARTICLES OF INCORPORATION

### OF

### ASIA-PACIFIC MEDICAL CENTER BACOLOD, INC.

### (formerly ALLIED CARE EXPERTS MEDICAL CENTER- BACOLOD INC.)

Know All Men By These Presents:

That we, of legal age, and residents of the Philippines, on this day voluntarily associated ourselves together for the purpose of forming a corporation under and in accordance with the laws of the Republic of the Philippines.

### And We Hereby Certify:

### <u>Article I</u>

That the name of the corporation shall be:

### ASIA-PACIFIC MEDICAL CENTER BACOLOD INC.

(As amended by at least majority of the members of the Board of Directors, and by the stockholders representing at least 2/3 of the outstanding capital stock of the Corporation at their respective meetings held on 23 May 2020 and 22 August 2020)

### Article II

That the purposes for which said corporation is formed are:

### Primary Purpose

To establish, maintain, operate, own and manage, hospitals, medical and related healthcare facilities and businesses such as but without restriction to clinical laboratories, diagnostic centers, ambulatory clinics, condo hospitals, scientific research and other allied undertakings and services which shall provide medical, surgical, nursing, therapeutic, paramedic or similar care, provided that purely professional, medical or surgical services shall be performed by duly qualified and licensed physicians or surgeons who may or may not be connected with the hospitals and whose services shall be freely and individually contracted by the patients.

# Secondary Purpose

1. To purchase, acquire, own, lease, sell and convey real properties such as lands, buildings, factories, and warehouses and machineries, equipments (except financial leasing)

and other personal properties as may be necessary or incidental to the conduct of the corporate business and to pay in cash, shares of its capital stock, debentures and other evidences of indebtedness, or other securities, as may be deemed expedient, for any

business or property acquired by the corporation.

2. To import, export, buy, sell or deal, as principal or in representative capacity or as a manufacturer's representative, in merchandise, drugs, pharmaceutical products,

medicines, chemical, cosmetics, perfumeries, toilets, articles, surgical apparatus, physician's and hospital's supplies, equipment, optical supplies, and such other materials related to the primary purpose.

3. To import, export, buy, sell and generally deal in all kinds of machinery, equipment as well as chemicals, appliances and instruments, extract, compounds and materials required for such operations and related to the primary purpose.

4. To establish, adopt and maintain a system of a prepaid professional, medical, nursing, paramedical and hospitalization services.

5. To own, manage, run, operate gift shops, magazine stands, drug stores, soda fountain, canteens, and refreshment parlors.

6. To borrow or raise money from not more than nineteen (19) lenders including its stockholders necessary to meet the financial requirements of its business by the issuance of bonds, promissory notes and other evidences of indebtedness, and to secure the repayment thereof by mortgage, pledge, deed of trust or lien upon the properties of the corporation or to issue pursuant to law shares of its capital stock, debentures and other evidences in payment for properties acquired by the corporation or for money borrowed in the prosecution of its lawful business to the extent permitted by law.

7. To invest and deal with the funds and properties of the corporation in such manner as may from time to time be considered wise or expedient for the advancement of its interest and to sell, disposed of or transfer the business, properties and goodwill of the corporation or any part thereof for such consideration and under such terms as it shall fit to accept.

8. To enter into any lawful arrangement for sharing profits, union of interest, unitization or farm out agreement, joint venture, reciprocal concession, or cooperation, with

any corporation, association, partnership, syndicate, entity, person or governmental, municipal or public authority, domestic or foreign, in the carrying on any business or transaction deemed necessary, convenient or incidental to carrying out any of the purposes of this corporation.

9. To acquire or obtain from any government or authority, national, provincial, municipal or otherwise, or any corporation, company or partnership or person, such charter, contracts, franchise, privileges, exemption, licenses and concessions as may be conducive to any of the objects of the corporation.

10. To establish and operate one or more branch offices or agencies and to carry on any of all its operations and business without any restrictions as to place or amount including the right to hold, purchase or otherwise acquire, lease, mortgage, pledge and convey or otherwise deal in and with real and personal property anywhere within the Philippines.

11. To apply for, register, hold, own, use, sell, assign, or otherwise dispense trademarks, trade names, patents, invention, formula and process in connection or resulting there form.

12. Subject to existing laws, to purchase, acquire, hold, dispose, of or otherwise deal in shares, stocks, bonds, securities of any corporation having subjects altogether or in part similar to those of the corporation and while the holder thereof, to exercise all the rights and incidents of ownership, including the right to vote the same and to receive dividends and dispose of the same.

13.Without limiting any of the foregoing purposes and objects, do and perform and conduct such acts of things whatsoever which are necessary or incidental to the purposes of the corporation and in general, to do perform and to exercise such powers.

14. To guarantee, for and in behalf of the corporation obligations of other corporations or entities in which it has lawful interest;

# That the place where the principal office of the corporation is to be established or located is in Lacson St., Barangay Bata, Bacolod City.<sup>1</sup>

## Article IV

That the term for which said corporation is to exist is FIFTY (50) YEARS from and after date of incorporation.

# Article VII

That the authorized capital stock of the Corporation is **TWO HUNDRED FORTY MILLION PESOS (P 240,000,000)**, Philippine Currency, and said capital stock is divided into two

hundred forty thousand (240,000) shares with a par value of One Thousand Pesos (P 1,000) per share divided as follows: (As amended by at least majority of the members of the Board of Directors, and by the stockholders representing at least 2/3 of the outstanding capital stock of the Corporation at their respective meetings held on 23 May 2020 and 22 August 2020)

- a) TWO HUNDRED THIRTY NINE THOUSAND FOUR HUNDRED (239,400) COMMON shares with a par value of ONE THOUSAND PESOS (Php 1,000) per share;
- b) SIX HUNDRED (600) FOUNDER shares with a par value of ONE THOUSAND PESOS (PhP 1,000) per share.

The rights, preferences, restrictions and qualification on the shares of stocks which shall be printed on the stocks certificate are as follows:

The holders of the founder shares shall have the exclusive right to vote and be voted upon in the election of directors for a limited period not to exceed five (5) years. The five (5) year period shall commence from the date of registration with the Securities and Exchange Commission.

Transfer or otherwise disposal of shares shall observe the following priorities:

- 1. First Priority to the corporation which must exercise its option within thirty (30) days from date of receipt of the written offer by the Secretary of the corporation.
- Second Priority to holders of founder shares who must exercise their option within like period of thirty (30) days from receipt of the written offer of the Secretary of the Corporation.
- 3. Third Priority to holder of common shares who must likewise exercise the option within a period of thirty (30) days from the receipt of the written offer by the Secretary of the Corporation
- 4. Fourth Priority to outsiders who must likewise exercise the option within thirty days from receipt of the written offer from the Secretary of the Corporation.

The issuance, sale and transfer of shares shall only be allowed if the transferee is qualified under Philippine laws. The issuance, sale and transfer of shares to persons or entities not qualified under the Philippine Laws, whether such issuance, sale, or transfer is voluntary or otherwise, shall not be recognized nor registered in the books of the Corporation. That in the event that the Corporation shall find that a stockholder is not qualified, or has in any manner lost his qualifications to own such stock, the Corporation, through its Corporate Secretary, shall notify the disgualified stockholder to transfer his shares in the Corporation to a qualified person within one (1) business day from receipt of notice, failing which the Corporation may acquire the shares into treasury, and subject to other requirements under the Corporation Code. If the corporation has no sufficient unrestricted retained earnings or is unwilling to acquire the shares, the Corporation, through its Board of Directors, shall have the right to designate any gualified and willing person to purchase the shares of the disqualified stockholder within such time as the Board may fix, at book value per share, as reflected in the latest audited financial statements of the Corporation. Upon payment or tender of payment of the shares to the disqualified stockholder, the Secretary of the Corporation shall be considered as the Attorney-In-Fact of the disgualified stockholder and shall have full authority to transfer the shares of the Corporation to the purchaser designated by the Board without need of further authorization from the disqualified stockholder, the disqualified stockholder, upon demand, shall surrender to the Corporation the certificates of stock, duly endorsed, for cancellation. The failure of the disqualified stockholder to surrender the certificates shall not, however, prevent the transfer from being registered in the books of the Corporation.

The foregoing restrictions shall not apply to the dispositions by the stockholders by will, donation, inheritance, bequest, and related transfer of said shares.

Any transfer of share of the capital stock in violation of the foregoing provisions shall be null and void and shall not be transferable in the books of the corporation.
