WHEREAS, the Corporation was duly incorporated under the Corporation Code of the Philippines (Batas Pambansa Blg. 68) with a corporate term of fifty (50) years as stated in its original Articles of Incorporation;

WHEREAS, Section 11 of the Revised Corporation Code of the Philippines (Republic Act No. 11232), which took effect on February 23, 2019, now provides that a corporation shall have perpetual existence unless its Articles of Incorporation provide otherwise;

WHEREAS, the Board of Directors has determined that it is in the best interest of the Corporation to amend the Articles of Incorporation in order to change its corporate term from a definite period of fifty (50) years to perpetual existence, to ensure the uninterrupted delivery of healthcare services and support long-term operations;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors hereby approves that Article IV of the Corporation's Amended Articles of Incorporation dated 06 November 2023 be amended from, to wit:

"ARTICLE IV

That the term for which said corporation is to exist is FIFTY (50) YEARS from and after date of incorporation."

"ARTICLE IV

That the term for which said corporation is to exist is perpetual from and after date of incorporation."

RESOLVED FINALLY, that the proper officers of the Corporation be, as they are hereby, authorized and directed to file the necessary documents and secure the requisite approvals from the Securities and Exchange Commission (SEC) and other relevant government agencies to effect said amendment.
